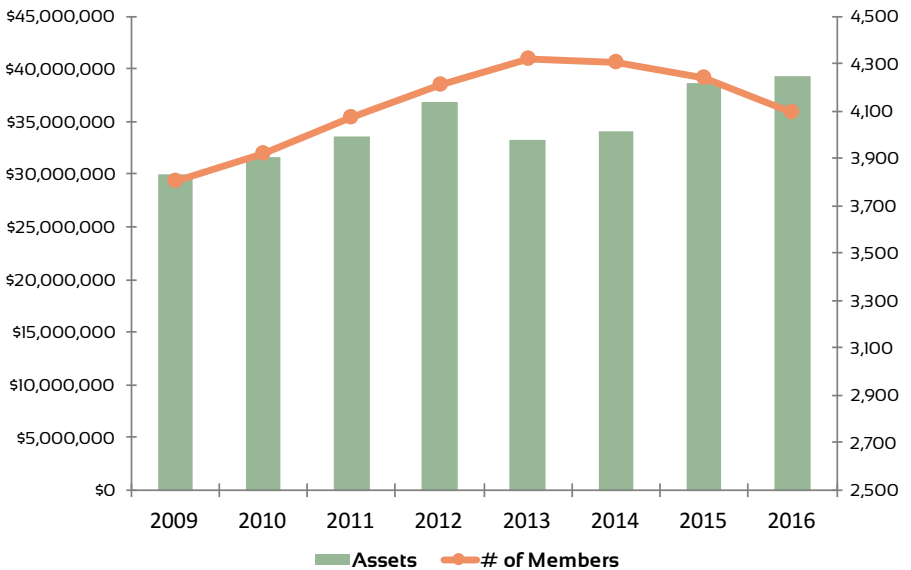

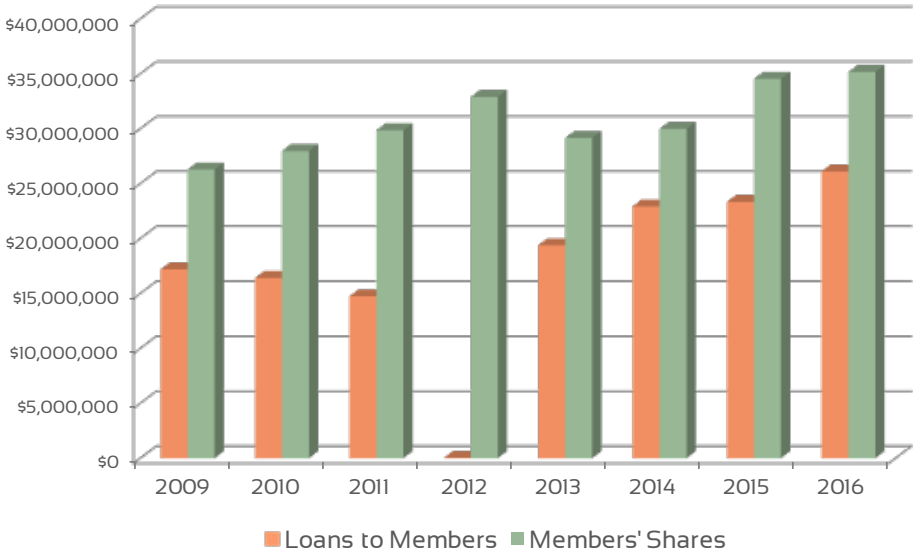
### Income and Expenses



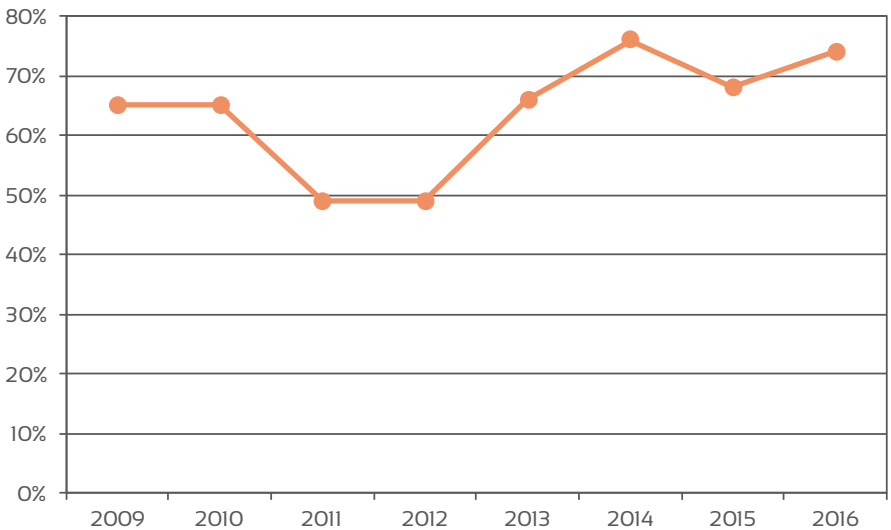
### Asset and Membership Growth
